TRAVIS COUNTY ORDER DESIGNATING CASES WHERE FILINGS ARE TO BE ELECTRONICALLY FILED AND ELECTRONICALLY SERVED AND SETTING FORTH CERTAIN REQUIREMENTS IN SUCH CASES

Upon the Court's own motion in accordance with the Local Rules of the Travis County Civil District Courts Concerning the Electronic Filing of Court Documents.

1. **DESIGNATION OF TEXASONLINE E-FILE CASE.**

IT IS HEREBY ORDERED that, henceforth, the types of cases specified in Attachment A filed in the District Courts of Travis County, Texas, shall be and they are designated TexasOnline E-File cases.

2. **ELECTRONIC SERVICE.**

IT IS FURTHER ORDERED that, in TexasOnline E-File cases, each party will register with TexasOnline for receipt of electronic service and those copies of each filing will be electronically served on all parties in the case.

3. **LIMITATION ON DISCOVERY FILINGS.**

IT IS FURTHER ORDERED that, in TexasOnline E-File cases, only the certificates of serving discovery requests and responses shall be E-filed; neither the request nor responses shall be filed nor need be filed.

4. **NO PAPER FILINGS RECEIVED.**

IT IS FURTHER ORDERED that the District Clerk shall not receive any petitions, applications, or pleadings whatsoever in TexasOnline E-File cases in paper form, except for filings by pro se parties or parties granted a waiver by the court. If the District Clerk receives a paper filing in a TexasOnline E-File case, the Clerk is ORDERED to return the paper filing to the purported filer with a notification that the case is to be E-filed through TexasOnline and that no paper filings can be received, file-stamped, or scanned.

5. **NOTICE OF ORDER**

IT IS FURTHER ORDERED that the District Clerk shall notify all parties in TexasOnline E-File cases, whether original defendants, cross defendants, or otherwise, advising of this order and of the requirements of the Travis County Local Rules of the District Courts Concerning the Electronic Filing of Court Documents. Such notification may be included with citation issued to any party or, if no citation is to be issued, then sent by any method specified in Rule 21a, Texas Rules of Civil Procedure.



6. **SHOW CAUSE OBJECTION**

If any party objects to such filing requirements, that party shall file a written objection within 30 days of the date of the order and set the matter for a hearing before Judge John K. Dietz to show cause why the electronic filing requirement is unduly burdensome in the particular case pursuant to Rule 15.3(b), Local Rules of Civil Procedure and Rules of Decorum. Hearings should be set with the 250th District Court and will be held Fridays of jury weeks at 11:00 a.m.
